 Budget spending averages FY23 and FY24 budget
 Assume payroll portions spent within Region 10
 Assume payroll spending in only 10 industries
 Assume portions of incremental gains
 IMPLAN averages employee compensation, output and other metrics across 546 industries
 Assume incremental broadband impacts based on
 - research literature guidance






IMPLAN

- Input-Output Model
 - Numerical analysis approach to modeling interdependencies between different sectors of an economy
 - Leontief wins Nobel Prize 1973
- IMPLAN developed by USFS in 1970s, later privatized
- Based on BEA, BLS, IRS, NOAA, etc, etc
- Perfect data model of regional economy
- Used to estimate changes to an economy as investment multiplies or ripples through an economy
