2. [Fleet Zero-Emission Resource Opportunity \(Fleet-ZERO\)](#)
 - a. "Funding electric vehicle (EV) charging to support the transition of light-, medium-, and heavy-duty fleets to electric vehicles."
 - b. Prioritized investment in disproportionately impacted communities and enhanced incentives for government agencies.
 - c. **Opens 10/16/23, Due 12/1/23 at 5pm.**
3. [Charge Ahead Colorado](#)
 - a. Grant funding for community-based Level 2 and DC fast-charging EV charging stations from the Colorado Energy Office.
 - b. Max funding is 80% with max incentive per charger dependent on the power level.
 - c. Enhanced incentives for income qualified and disproportionately impacted communities.
